POSITIVE PROFIT ALERT

This announcement is made by Man King Holdings Limited (the “**Company**”, and together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09(2)(a) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board of directors of the Company (the “**Board**”) wishes to inform shareholders of the Company (the “**Shareholders**”) and potential investors that based on the preliminary review of the latest available unaudited consolidated management accounts of the Group for the year ended 31 March 2026, the Group is expected to record a net profit ranging from approximately HK\$6.0 million to HK\$9.6 million for the year ended 31 March 2026 as compared to a net loss of approximately HK\$21.1 million for the year ended 31 March 2025. The expected turnaround from loss to profit for the year ended 31 March 2026 was mainly attributable to (i) the improvement of gross profit of several construction projects for the total work completed, including variation orders carried out by the Group during the year and (ii) absence of one-off impairment of financial assets of approximately HK\$11.8 million recognised for the year ended 31 March 2025.

As at the date of this announcement, the Company is still in the process of finalising the Group's results for the year ended 31 March 2026. The information contained in this announcement is only based on the preliminary review assessment by the Board of the information currently available to it including but not limited to the latest available unaudited consolidated management accounts of the Group for the year ended 31 March 2026, which have neither been reviewed by the audit committee of the Company nor reviewed or audited by the Company's auditors. Such financial information will be subject to finalisation and necessary adjustments. Accordingly, the actual results of the Group for the year ended 31 March 2026 may differ from the information contained in this announcement. Shareholders and potential investors are advised to refer to the annual results announcement of the Company for the year ended 31 March 2026 which is expected to be published in late June 2026.

Shareholders and potential investors should exercise caution when dealing in the shares of the Company.
